**ASSISTANT PROFESSOR ( For Post Code-1 to 13) E.Q:** (i) (1). A Recognized veterinary qualifications included in the first and second schedule in Indian Veterinary Council Act; 1984 & must be registered with a State Veterinary Council/Veterinary Council of India. (2). B.V.Sc. & A.H. (Bachelor of Veterinary Science & Animal Husbandry) with at least 55% marks or its equivalent grade in the point scale. (3). Master degree in the concerned discipline with at least 55% marks or its equivalent grade in a point scale with consistently good academic record.
